MINUTES OF THE BOUSE VOLUNTEER FIRE DISTRICT BOARD MEETING MARCH 8, 2016

CALL THE MEETING TO ORDER: Chairman Doug Williams called the meeting to order at 5:03 pm. Followed by the Pledge of Allegiance

ROLL CALL OF OFFICERS: MEMBERS PRESENT: Doug Williams, Jack Anderson & John Nault

APPROVAL OF MINUTES: February 9, 2016 Board Meeting: John Nault made a motion to approve

the minutes as presented. Jack Anderson seconded the motion. Vote Aye 3

Nay 0 Motion Carried.

February 9, 2016 Executive Session Minutes: Jack Anderson made a motion to approve the minutes as presented. John Nault seconded the

motion. Vote Aye 3 Nay 0 Motion Carried.

APPROVAL OF FINANCIAL REPORTS: Treasurer Anderson presented the financial reports for February 2016. We had revenue of \$48,566.49 and expenses of \$7,170.82. Our ending bank balance was \$158,666.03. There are 3 outstanding warrants totaling \$307.00. Discussion followed. We received a little bit more on the Fire Assistance tax than anticipated. This was from a couple of years when the county sorted us. John Nault asked why there was a different price on the fingerprint cards for the Fire Department then the school district. Discussion followed on the process required and the nature of the background completed by DPS. Jack Anderson made a motion to approve the financial reports for February 2016. John Nault seconded the motion. Vote aye 3 Nay 0 Motion carried.

CORRESPONDENCE: Treasurer Anderson said she received information from the Elections Department. The next consolidated election is August 30. None of our board member's terms are up until the November election. We also received our 2016 levy limit report to work on for our next budget. She also said we ran a call where the patient was deceased and we normally we do not bill on these types of calls.

CHIEF'S REPORT: Chief Lowe reported we ran 24 calls for service in February (including 15 EMS, 2 Haz-Mat, 2 vehicle fires, 1 residential fire). To date we have run 41 calls. He had to replace the batteries on 5504 and put a new siren in 5551. He is still working on getting the title for the old red pickup. We will begin getting an invoice for one some of the drugs we use. The price has gone up and IMD will no longer pickup the total cost. Discussion followed on several items.

CALL TO THE PUBLIC: We had a guest from an all-volunteer fire department in Navada attend the meeting. He said many of our issues are identical to his department. The main one is being unable to get volunteers. Most of his volunteers are older. Their youngest is over 50 years old. John Nault asked about what we would need to do to increase our District Boundaries. Discussion followed. It is a multi year process requiring several public votes, one by the existing district property owners and then one by the property owners of the proposed areas. Discussion followed.

FINANCIAL REVIEW – SAUNDERS COMPANY: The Jim Sanders was contacted by telephone. The annual financial report was done via telephone. The board members received printed reports. Doug Williams said we have received and reviewed the Financial Reports as presented.

Jack Anderson his concern is that we maintain the water capacity to meet our ISO requirement. With the disposal of this old engine we would still be in compliance. Jack Anderson made a motion to approve the donation of the old engine. The motion died for a lack of a second. The other board members thought we should look at selling it instead of donating it.
- D. Invoice from Sunset Emergency Physicians in the amount of \$85.00: This as for a pre-employment physical. Jack Anderson made a motion to approve payment of the invoice. John Nault seconded the motion Vote Aye 3 Nay 0 Motion carried
- E. Formal acceptance of donation of \$400.00 from the Ocotillo Lodge. Jack Anderson made a motion to accept the donation. John Nault seconded the motion vote Aye 3 Nay 0 Motion carried. George Nault asked that the donation be earmarked for the building fund.
